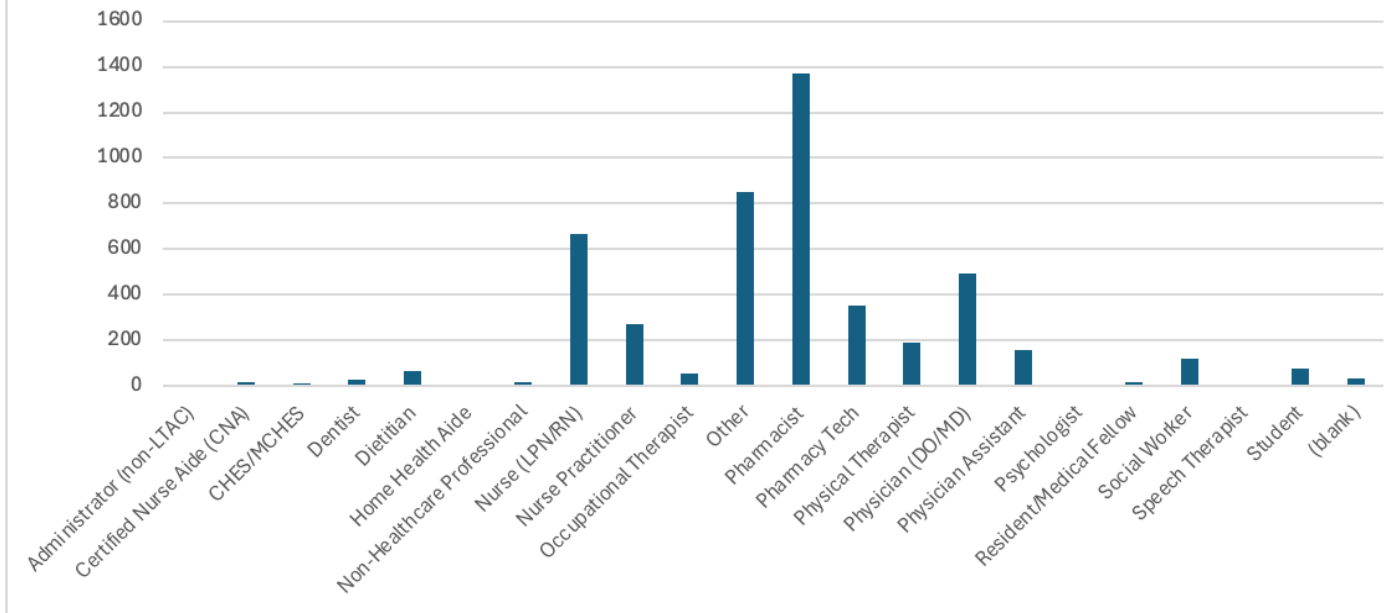

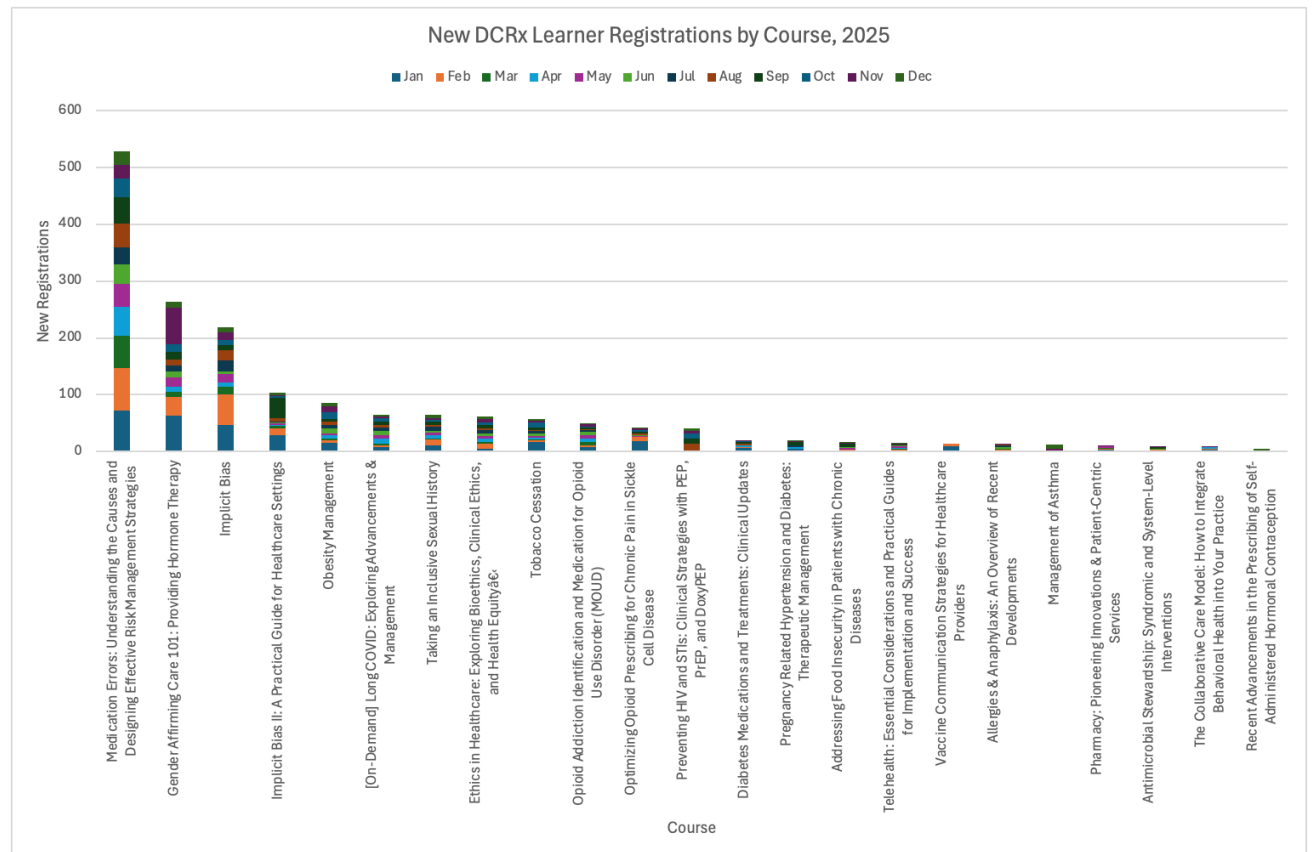
In 2025, there were **4,789** new registrations in the DCRx platform.

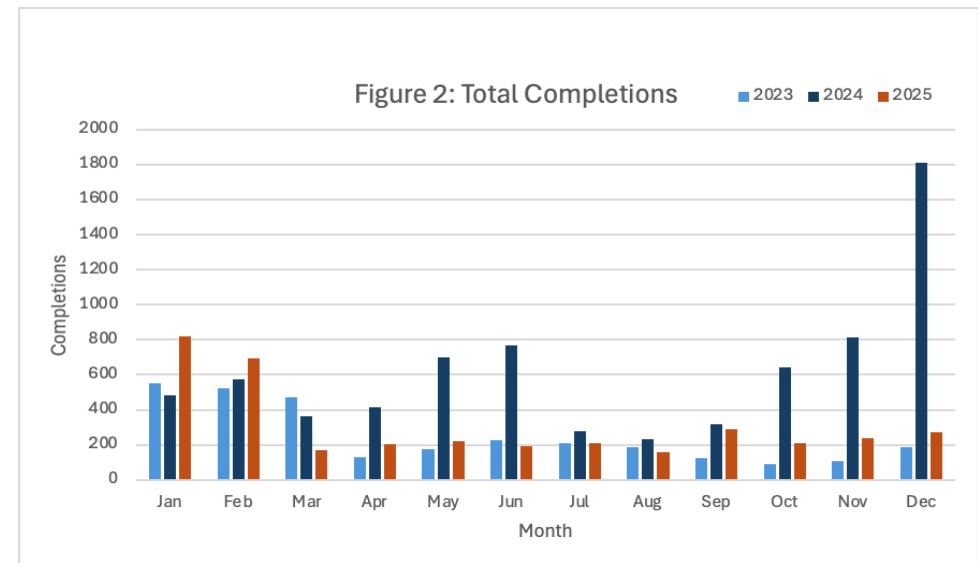
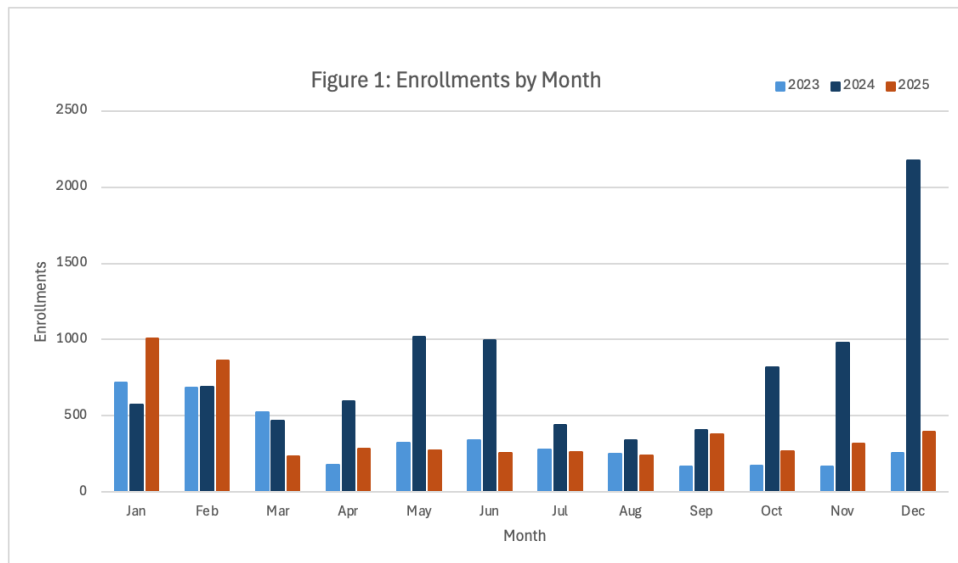
# 2025 NEW MEMBER COURSE ENROLLMENTS

- **Medication Errors: Understanding the Causes and Designing Effective Risk Management Strategies** had the highest number of new member enrollments (528) in 2025, followed Gender Affirming Care 101: Providing Hormone Therapy with the next highest number of enrollments (263), and Implicit Bias (218).
- 25% of learners will take one of these courses first after registering for DCRx.



# 2025 MONTHLY COURSE ENROLLMENTS & COMPLETIONS

Please note that the enrollment and completion numbers balanced out throughout the year because pharmacist license renewals now align with the licensee's birth month, with licenses expiring on the last day of that month (even birth months renew in even years and odd birth months in odd years). This system applies to licenses issued after June 16, 2024, and to all existing licenses beginning with the renewal period after July 31, 2025.

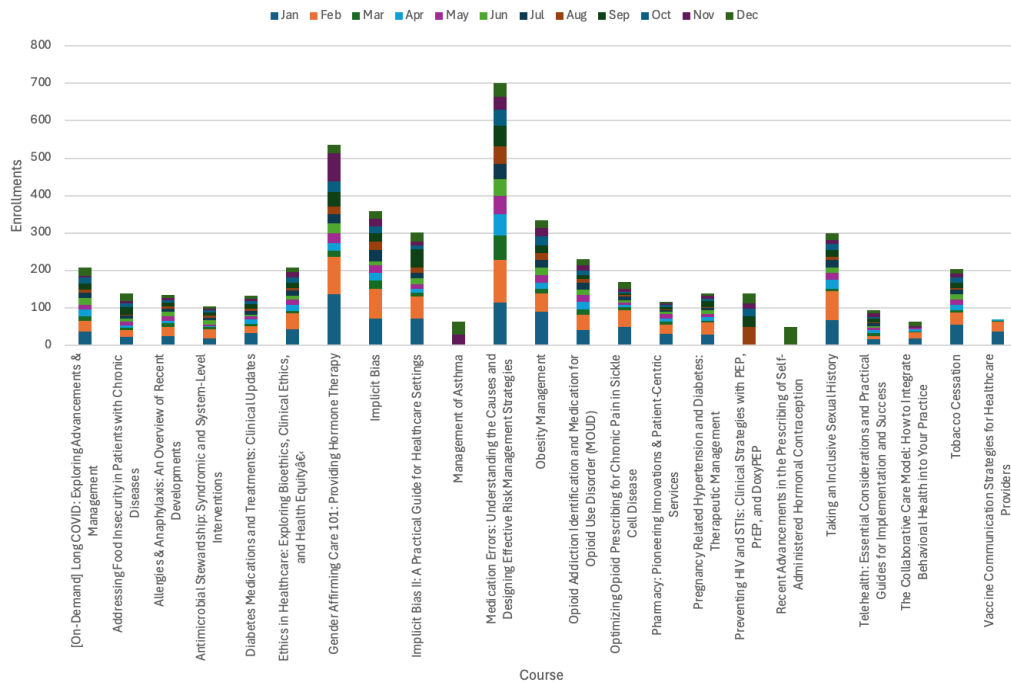


**4,700+ enrollments and 3600+ completions**

✓ **January** recorded the highest number of enrollments (**1,006**) and completions (**820**), followed by February with the second highest learner data.

# 2025 MONTHLY COURSE ENROLLMENTS & COMPLETIONS

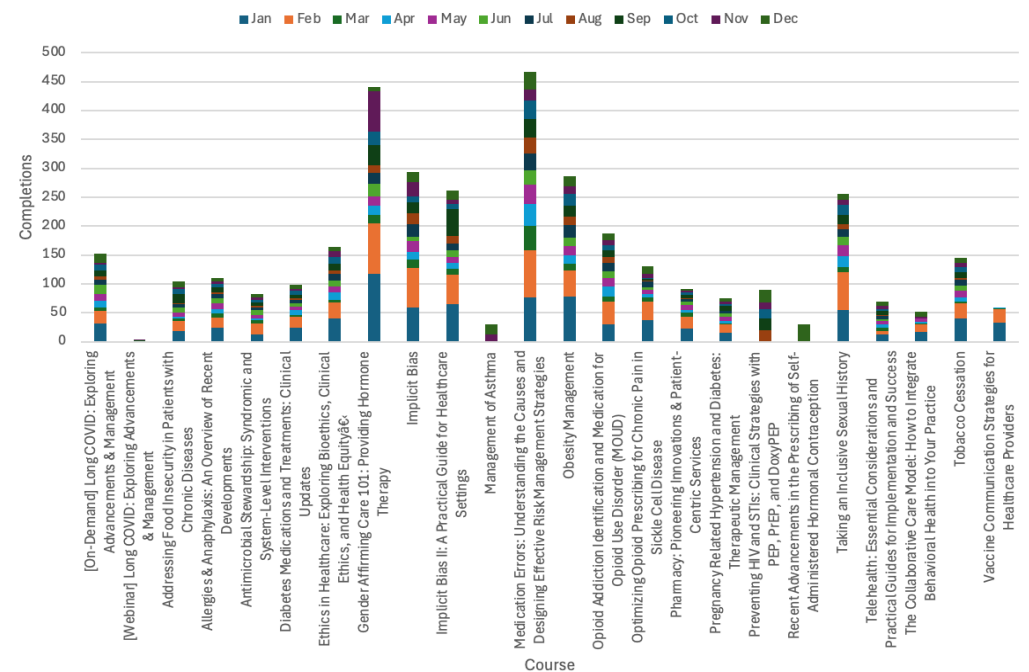
Figure 4: Course Enrollments by Month, 2025



- ✓ **Gender Affirming Care (GAC) 101: Providing Hormone Therapy** had the second highest completions (441), following closely behind Medication Errors course.
- ✓ GAC also had a significant learner spike in November.

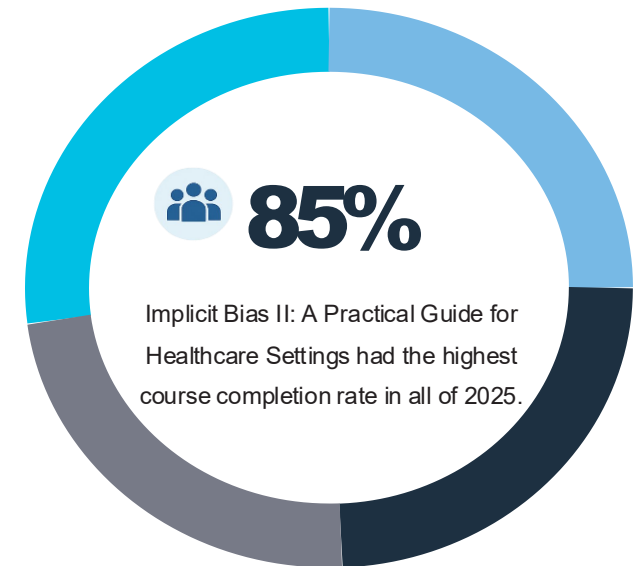
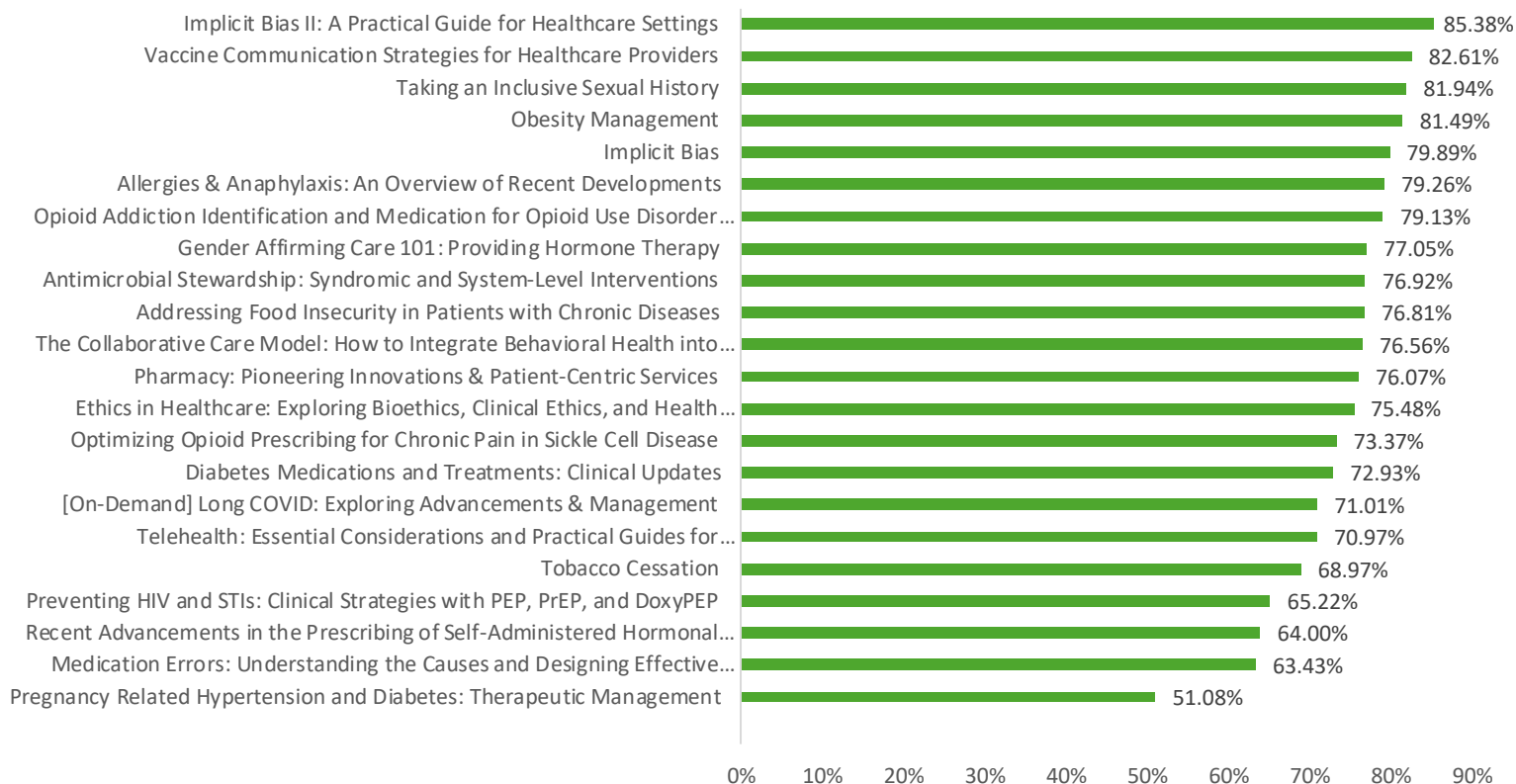
- ✓ **Medication Errors: Understanding the Causes and Designing Effective Risk Management Strategies** had the highest number of enrollments (700) and completions (467) out of any course in 2025.
- ✓ **January** and **February** had the highest enrollment and completion data across almost all courses.

- **Preventing HIV and STIs: Clinical Strategies with PEP, PrEP, and DoxyPEP** had the highest course completion rate compared to the two other courses released in 2025.
- The median completion rate for all courses is **73%**

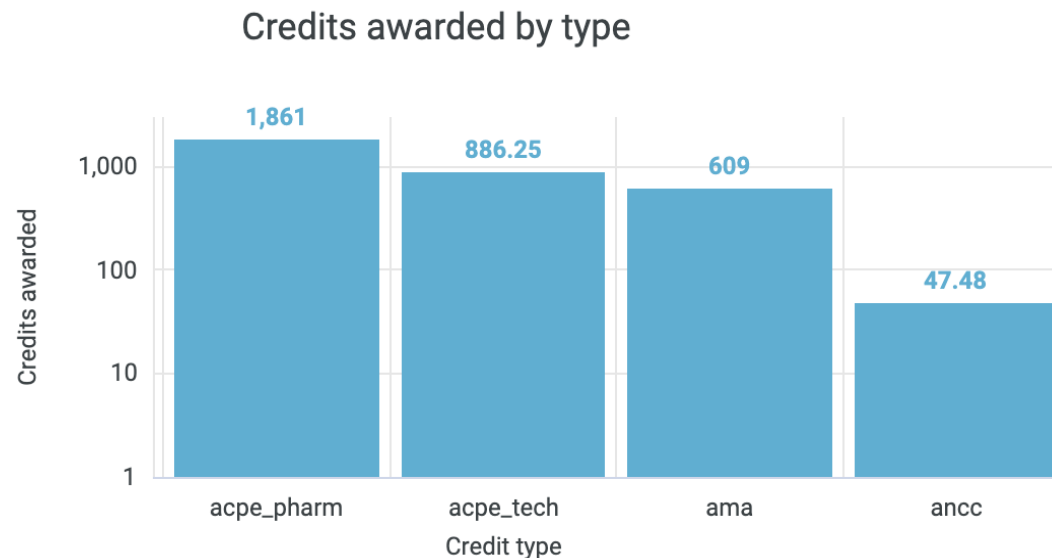

# POST-COURSE EVALUATION

## FEEDBACK

### Key Suggestions

- All courses demonstrated a high level of satisfaction, with only 2 out of 148 learners reporting they were not satisfied with the course. This suggests the modules are well-designed to meet online learning needs.
- 98% of learners reported that they agree that the information in the module will help them improve their interprofessional collaboration and practice.
- All learners from the course library reported improvements as a member of a care team, specifically in medical knowledge (30%) and patient care and procedural skills (20%)
- Throughout all courses, learners showed an increase in knowledge of the learning objectives after completing the modules.
- 94% of learners prefer to receive CME through online CME rather than live events
